# 1. Academic Transcript

## Transcripts from Colleges or Universities outside the United States...

If you attended a college or university outside the United States, you must provide an official evaluated transcript (not from you to us, but from the evaluating agency to us). Please do not send any transcript directly to us that is from a college or university outside of the United States--send it to an evaluating agency.

## Transcripts from American Colleges or Universities ...

If you attended an American college or university, you must provide the final official degree awarding transcript before you application can be reviewed. If you attended an American college or university and wish to transfer credits into Virginia State University, please so indicate at the time of application and provide an official transcript supporting the gradate credit transfer.

# 3. Processing deadlines

You must apply well in advance so that your file may be reviewed and your admission processed, the Form I-20 issued and processing time for your courtry's immigration requirements.

The certification process must be completed prior to **December 1st**, for the **Spring semester**.

The certification process must be completed prior to **July 1st** for the **Fall semester**.

Please submit all required docuemnts at least one month in advance of these deadlines.

After that date, your admission to VSU will be deferred to the next available academic term.

# 4. Health History

All first-time graduate students are required to provide a complete health history and proof of immunization to Student Health Services. The CERTIFICATION OF IMMUNIZATION must be completed fully and accurately by the student's health care provider prior to matriculation at Virginia State University. #### 6. Form I - 20

If you already have a Visa or permanent residency card, submit these to the International Student Advisor.
