



# FY2024 BUDGET OVERVIEW & FY 2025 PROPOSED TUITION AND FEES











#### **PROPOSED TUITION & FEES FOR 2024-25**

Wirginia State University is planning a 3% increase to its undergraduate and graduate in-state and out-of-state tuition, fees, room and board rates for 2024-25. The increase is to address continued inflationary pressures as well as anticipated increased costs for public safety, health services and technology.


