Ms. Pamela Currey, Chair, called the Academic and Student Affairs Committee meeting to order at 9:00 a.m. The meeting was held in the Gateway Dining & Event Center located on the campus of Virginia State University.

INVOCATION

Chair Currey invited Pastor Seth Gooden to offer the invocation.

APPROVAL OF AGENDA

The Committee approved the agenda by voice vote.

APPROVAL OF PREVIOUS MEETING MINUTES

The Committee approved the minutes from the February 9th meeting by voice vote.

PRESIDENT'S REMARKS

President Abdullah welcomed the board members back to the campus and thanked them for their service. He thanked Dr. Palm and his team for their diligence and hard work which will be evident in their presentations. President Abdullah introduced new SGA President for 2023-2024 – Kailyn Haye who joined the Committee meeting.

CLOSED SESSION

The Chair asked for a motion for the Committee to enter a closed meeting for the discussion or consideration of personnel matters pursuant to 2.2-3711 (A) (1), specifically relating to: promotion and tenure and discussion or consideration of information pursuant to §2.2-3711 (A) (11), specifically to: confer honorary degrees and faculty emeritus. The motion was received and properly seconded.

Upon returning to open session, the Chair asked for a motion for the Committee to certify that during its closed meeting, the Committee discussed only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act, and only those public business matters identified in the motion convening the Committee in closed session. The motion was received and properly seconded. The Committee voted by roll call.

The Chair requested a motion to recommend approval of the candidates for honorary degrees, promotion and tenure, and faculty emeritus to the Full Board. The motion was received and properly seconded. The Committee voted by roll call.

REPORTS AND RECOMMENDATIONS

Dr. Palm presented Dr. Dawit Haile, Dean of the College of Engineering & Technology, to give a brief overview of the College of Engineering & Technology (CET) at Virginia State University (VSU). Dr. Haile shared information relative to the CET degree programs, student job placement, accelerated graduate programs, student successes in the doctoral programs at the University of Virginia, Virginia Tech, and examples of current industry led projects, which academically and financially support students in the CET. Discussion followed regarding the vision of the CET and the plans for continued growth in the number of students in the CET programs. The Chair thanked the Dean and his faculty for their work and

reminded the committee members they would have an opportunity to visit the College today after the committee meeting.

Dr. Alexis Brooks-Walter reported on Enrollment Recruitment, Retention, and Housing. She informed the Board of the strategic enrollment plan which VSU initiated a few months ago. She explained the "enrollment cliff" and the model used by consultants to make predictions for VSU. Discussion followed and in response to comments, Dr. Brooks-Walter indicated that VSU is aware of potential challenges such as declining enrollment, losing faculty, and time to degree approval. VSU is working through a strategic thinking process that includes consideration of challenges that may arise.

Dr. Tia Minnis presented information on the new programs and proposal review process. She shared steps in the review process that the University undergoes with the State Council of Higher Education for Virginia (SCHEV). Dr. Minnis also presented degree programs for the Committee's recommendation for approval; i.e., Graduate Certificate in Ed Admin & Supervision; Masters of Business Administration; BS in Mechanical Engineering; and the MS in Data Analytics Engineering.

Chair Currey asked for a motion to recommend approval of the four degree programs to the Full Board. The motion was received and properly seconded. The Committee voted by roll call vote.

Ms. Regina Barnett-Tyler gave updates on the Student Success and Engagement Division, in general, and the Generation Hope FamilyU Cohort and the Child Care Access Means Parents in School (CCAMPIS) grants, in particular. Ms. Barnett-Tyler shared her excitement that the program directors/coordinators are in place and the programs are going very well. She also expressed gratitude to Chair Currey for bringing these grant opportunities to the University's attention.

Chief David Bragg gave public safety and police report updates on campus safety and briefly discussed recent incidents. Chief Bragg shared his appreciation for the new technology which has assisted the department to protect the campus community. The Chair thanked Chief for his work and asked that he share the Board's thanks with his team. She also applauded the Technology Services leadership for their role in assisting the Police Department with implementation of the new technology.

President Abdullah briefly gave an update on the Governor's request to develop a statement on free speech and thanked Dr. Githinji and the Faculty Senate for their assistance in the effort. Chair Currey stated that VSU wanted the Board to know that it is going through the process and includes Faculty Senate.

ADJOURNMENT

There being no further business, Chair Currey called for a motion to adjourn the meeting. The motion was received, properly seconded, and the committee voted by voice vote. The Chair adjourned the meeting at approximately 11:40 a.m.
