# **INVOCATION**

Chair Gordon invited Pastor Graham to offer the invocation.

# **APPROVAL OF AGENDA**

The Committee approved the agenda by voice vote.

# **APPROVAL OF PREVIOUS MEETING MINUTES**

The Committee approved minutes from the April 22, 2022 meeting by voice vote.

# PRESIDENT'S REMARKS

The President expressed his excitement about the presentations that the Institutional Advancement team would give today.

### **REPORTS AND RECOMMENDATIONS**

Ms. Tonya Hall, Vice President for External Relations, presented an overview of the Office of Institutional Advancement along with roles, responsibilities, and alignment with the University's current Strategic Plan--*Preeminence with Purpose*. Ms. Hall shared a history of institutional advancement which included definitions of advancement, development, and fundraising; and she presented generalized profiles of an individual donor and a corporate donor.

Ms. Hall also introduced staff members who shared case studies to demonstrate the anatomy of gifts (individual partnerships and corporate partnerships): Mr. William Sawyer, Director of Corporate and Foundation Relations; Eldon Burton, Asst Vice President/Director, Government Relations; and Dr. Gwendolyn Williams Dandridge, Asst. Vice President/Director, Communications.

Mr. Franklin Johnson-Norwood, Director of Alumni Affairs, also gave an update on initiatives to engage alumni and steward them toward giving such as the VSU Virtual Book Club, Oral History Project for alumni to share about their time at VSU; Homecoming 2022 events; and The Greater Pathway Brick Campaign. Ms. Courtney Grice, Advancement Specialist, shared information about the Homecoming 2022 Trojantic Match It Challenge from October 8–10, 2022. This initiative, along with other alumni engagement initiatives, will help us to grow the number of alumni who count Virginia State University in their top five organizations to support philanthropically.

Ms. Hall stated that philanthropic support to VSU totaled \$4,753,448.52 for the Fiscal year 2022. This data represents a \$956,003 or a 25% increase over the previous year. And while we can applaud the

increased amount raised, we must keep an eye on the decline in the number of donors. However, by industry standards, 45.5% of donors are retained yearly, and the average donor's lifespan is 4.6 years. The Office of Institutional Advancement is currently planning a strategy to get ahead of attrition and engage students before they become alumni. Corporate, Foundation, and Organization philanthropic support to VSU totaled \$2,939,605.27, a \$1,211,960 or 70% over the previous year. Philanthropic support totaled \$557,549.16 for Tuition Assistance. This data is not only 17% over last year's total but also the first time we have exceeded our annual goal of \$500,000.

Ms. Hall highlighted Mission Moments initiated to recognize and celebrate alumni who have donated to the University through the Powell Society (alumni bequests) and/or the 1882 Society (alumni who have donated 10 consecutive years).

# Communications

Dr. Gwendolyn Williams Dandridge gave an update from the VSU Office of Communications. The Communications team began a significant campus branding project which primarily focused on the entrance to campus. In addition, the perimeter of the VSU campus has been lined with six different VSU flags. The north entrance police hut has been branded with the VSU logo. There is new signage and a hero image listing the names of all VSU student organizations. Logo stamps are on the roadway leading into and out of campus. A major athletic initiative involves a newly updated football stadium which our team had the pleasure of branding. The team also added more branding for photos taken at Commencement.

The Communications team has worked to keep the VSU name in the media in a positive light. The team has had numerous success stories including the Kyle Jacobs story, a VSU athlete who appeared in VSU gear on the Today Show, and our graduate teaching initiative. The team has also taken on the task of transportation branding to include branding signage at the airport, train station, covering buses, running radio ads, signage on transportation signs, and t-shirts for local high schools.

There being no further business, Chair Gordon called for a motion to adjourn the meeting. The motion was received, properly seconded, and the committee voted by voice vote. The Chair adjourned the meeting at 2:05 p.m.
