# VIRGINIA STATE UNIVERSITY BOARD OF VISITORS EXECUTIVE COMMITTEE MEETING MINUTES Wednesday, November 13, 2019 9:30 a.m., Room 310 Virginia Hall

# **APPROVAL OF PREVIOUS MINUTES**

The last Committee meeting was the Strategic Plan Advisory Subcommittee meeting on January 31, 2019. Those minutes were approved at the February 8<sup>th</sup> Board meeting.

President Makola M. Abdullah shared a few highlights about the Trojan football and men's basketball teams.

### DISCUSSION

#### **Board Governance**

The Rector indicated that the purpose of this meeting was to follow up on discussions at the August 2019 Retreat on how to move toward becoming a high performance Board. The *Code of Virginia* §23.1-1306 is the guiding document for the Board's Executive Committee. Today's discussion will focus on how the Executive Committee will move the Board forward and what recommendations the Committee will make to the full Board.

The Committee addressed the duties of the Executive Committee and subcommittees and discussed Board assessment tools and a member matrix/needs assessment. After further discussion, the Committee agreed to recommend three motions to the full Board.

- Motion: Recommendation to the full Board to change the responsibilities of the Personnel & Compensation committee to include governance
- Motion: Recommendation to the full Board to change the Bylaws to modify the responsibilities of the Personnel & Compensation Committee
- Motion: Recommendation to the full Board to adopt a Board Performance assessment tool and the Board Member Matrix

### Board Elections

Board elections for 2020-2022 will take place at the Annual Meeting on April 24, 2020. Vice Rector Hill will conduct the Board's officer nomination and election process. The timeline for the process begins with the call for nominations at the February 7, 2020 meeting.

#### Review of the VSU Draft Public Comment Policy

The Public Comment Policy was drafted based on the Code of Virginia guidelines §23.1-307 (E) and a review of existing policies adopted by other Commonwealth institutions. Ms. Currey recommended that the administration provide a presentation on the budget for the public and students before the public comment meeting. Board members should receive the same information. Language will be added to the Policy Statements section of the Public Comment Policy.

#### Updates

Ms. Crittenden shared information about the partnership with the Hampton Roads Community Action Program. The partnership is expected to expand the VSU brand in the Hampton Roads region and identify programs and opportunities that would 1) bring students to VSU, and 2) generate more money from the Hampton Roads region. Recently, 30 students from the Hampton Roads area visited VSU as part of the Project Discovery Program. The program works with students to help first-generation students (8<sup>th</sup> grade through college) prepare for college.

Ms. Currey shared information about a pending statement from the Governor announcing a partnership with the Lumina Foundation for talent, innovation, and equity. The partnership would create equity champions for higher education around the state. Ms. Currey asked for recommendations of persons who could serve in this role.

Mr. Sessoms shared that he and Ms. Crittenden will tour the VSU Archives today to see what is housed there. They also shared a few ideas of how the University can capture the history of older alumni to help tell the VSU story.
