Ms. Ramona Taylor, University Legal Counsel, provided an update on revisions (committee duties and laws based on changes to the *Code of Virginia*) that will be necessary for the Board Bylaws. The Rector asked Legal Counsel to remind the Board of this agenda item for the August 2018 Retreat.

REMARKS FROM FACULTY AND STUDENT REPRESENTATIVES TO THE BOARD

Rector Black invited Dr. James Norman, Faculty Representative, and Cody Mitchell, Student Representative, to the podium to give remarks on behalf of their respective constituents. This was the final Board meeting for Dr. Norman and Mr. Mitchell as their terms in office expire at the end of spring 2018 semester. Both gentlemen expressed appreciation to the Board and the University administration for the opportunity to serve. President Abdullah thanked Dr. Norman and Mr. Mitchell for their service and leadership in moving the Faculty Senate and the Student Government Association forward and working with the administration to address concerns.

The Rector recognized Ms. Paula McCapes, President of the Staff Senate, who briefly shared the Senate's plans for growth and programing.

BOARD RETREAT ACTION PLAN FOLLOW-UP/THE BOARD'S SELF-EVALUATION

Ms. Crittenden and Ms. Hunter will work together to plan the Board's 2018 Retreat and advise in the University's orientation of new Board members. Ms. Crittenden requested Board members to express their views as reflections and/or assessment of the Board's performance in the April 2018 Annual Meeting. Mr. Black, the outgoing Rector, gave a charge to the Board and the University to continue working to: pursue level II status, maintain impetuous change and diversity, continue being productive, be creative with tuition assistance - any qualified student should never have to worry about finances, continue the tremendous progress made in shared governance, practice continuity in leadership, explore land grant initiatives, and employ data analytics.

Ms. Crittenden expressed appreciation to Rector Black because in 2014 he had to balance the current situation with new Board members who wanted to implement changes. Ms. Crittenden asked Board members to submit questions for the Peer to Peer Question and Answer Worksheet. The worksheet will be revised and distributed to new members at the New Board Member Orientation in August 2018.

SPECIAL PRESENTATION

President Abdullah presented the Presidential Medal to Rector Harry Black who served two terms (8 years) on the Board (Mr. Black's second term expired on June 30, 2018). The Presidential Medal is the highest award given by the President for significant contribution to support the mission and vision of Virginia State University. This includes service, volunteerism, advocacy and visibility that provides significant advancement for Virginia State University. The gallery expressed appreciation to Mr. Black.

RESOLUTION AUTHORIZING THE OPERATING BUDGET FOR FISCAL YEAR 2018-2019

April 27, 2018

WHEREAS, the Board of Visitors, has today given consideration and approved tuition and fee rates for Fiscal Year 2018-2019, within the limits set by the Commonwealth of Virginia as proposed by the Governor, based on the 2017 Virginia Acts of Assembly, Chapter 836; and

WHEREAS, the tuition and fee rates approved for Fiscal Year 2018-2019 as presented by the Administration are deemed reasonable and consistent with past Appropriation Acts; and

WHEREAS, the appropriations to the University, which authorize the state funding and spending authority for the University, including the Cooperative Extension and Agricultural Research Services budget, but not including local University or VSU Foundation funding, are limited to the amounts and conditions in the Act; and

WHEREAS, the University has forecast revenue collections from all sources for Fiscal Year 2018-2019, based on conservatively anticipated enrollment levels; and

NOW, THEREFORE, BE IT RESOLVED, the Board of Visitors approves the Proposed Operating Budget appearing on the attached Table I; and

BE IT FURTHER RESOLVED THAT, the Board of Visitors approves the Educational and General (E&G) Budget appearing on the attached Table I; and

BE IT FURTHER RESOLVED THAT, the Board of Visitors approves the budgeted amounts for the Auxiliary Enterprise programs as appearing on Schedule I; and

BE IT FURTHER RESOLVED THAT, the Board of Visitors approves the budgeted amounts for the Cooperative Extension and Agricultural Research Services ("CEARS") programs as appearing on Schedule II; and

BE IT FURTHER RESOLVED THAT, the Board of Visitors approves expenditures in support of Sponsored Programs that have been properly awarded to the University and up to the amounts for which cash will be made available during the course of Fiscal Year 2018-2019 or as appearing in Table I; and

BE IT FURTHER RESOLVED THAT, the Board of Visitors authorizes the President to allocate and cause to be expended tuition, room, board, comprehensive and other fees collected beyond base projections, up to the amount appropriated and adjustments required and allowed by language in the Act, any additional General Fund Appropriation which may be corporated in the final Appropriation Act and also to reallocate and expend all unexpended

fiscal year 2017-2018 Educational and General and Auxiliary Enterprise funding that may be reappropriated for use in fiscal year 2018-2019 and to expend local funds available to the University should the need arise; and

BE IT FURTHER RESOLVED THAT, the University President shall provide to the Board, at its next regular scheduled board meeting, a presentation of the actual budget distribution.

RESOLUTION AUTHORIZING THE TUITION AND FEES FOR ACADEMIC YEAR 2018-2019

April 27, 2018

WHEREAS, the Commonwealth of Virginia funding policies and the impact of the economic forecast for the foreseeable future contained in the 2016-2018 Biennium Appropriations Act ("Act"); and

WHEREAS, the Act requires each institution to communicate its tuition and fee policy, as approved by the Board of Visitors to the Secretary of Education, the State Council of Higher Education for Virginia ("SCHEV"), and the Chairs of the House Appropriations and Senate Finance Committee by May 15 of each fiscal year; and

WHEREAS, the Board of Visitors has considered the proposed schedule of tuition, room, board, comprehensive, and miscellaneous fees, identified as Schedules A, B, C, D and E (attached); and

WHEREAS, the rates set for tuition, room, board, comprehensive, and miscellaneous fees, together with administrative actions to control costs, are intended to provide adequate coverage for basic instructional activities, related administrative support, other program and operating costs, and adequate debt service reserves for past and future construction projects utilizing bonded funds.

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Visitors of Virginia State University approves the tuition, room, board, comprehensive, and miscellaneous fees, found on Schedules A, B, C, D, and E, to be charged to students during the 2018-2019 academic year.

BE IT FURTHER RESOLVED THAT, the President shall monitor any subsequent actions of the General Assembly between now and the beginning of Fiscal Year 2019 for legislative impact on the tuition and fee policy and related funding, and shall implement timely changes required by such legislation, and shall report such action to the Board of Visitors at its next regularly scheduled meeting; and

BE IT FURTHER RESOLVED THAT, the President is authorized to establish miscellaneous fees for items not listed in Schedule D, in response to emerging needs and changing circumstances.

ANNUAL REVIEW OF COMPOSITE FINANCIAL INDEX (CFI)

WHEREAS, the Composite Financial Index (the "CFI"), developed by KPMG and Prager, Sealy & Co., LLC, provides an indicator of financial health at a point in time for institutions of higher education by means of a weighted composite score from the following four ratios (the "Component Ratios"):

- Primary Reserve Ratio
- Viability Ratio
- Return on Net Assets Ratio
- Net Operating Revenues Ratio

WHEREAS, examining the trend of an institution's CFI score over an extended period offers a long-term view of an institution's financial performance; and

WHEREAS, the Vice President for Finance and Chief Fiscal Officer of Virginia State University (the "CFO") has presented the CFI and Component Ratios to the Facilities, Finance and Audit Committee (the "Committee") of the Board of Visitors of Virginia State University (the "Board"). The CFO has also presented historical values for the CFI and Component Ratios along with schedules reconciling the Component Ratios to relevant line items of the financial statements of Virginia State University; and

NOW, THEREFORE, BE IT RESOLVED, the CFO will be responsible for presenting to the Committee and the Board annually the CFI, the Component Ratios, historical values for the CFI and Component Ratios, and schedules reconciling the Component Ratios to relevant line items of the University's financial statements.

IT IS FURTHER RESOLVED, that is the intent of the Committee and Board that the CFI will be an important, but not exclusive, measure of financial health and stability, and that the Committee and Board will consider the CFI, together with other data and measurements they have used and may continue to develop and examine, in the discharge of their duties as stewards of the finances of the University.

WHEREAS, Justin Edward Fairfax served as an Assistant United States Attorney for the Eastern District of Virginia in the Major Crimes and Narcotics Unit of the Alexandria Division; appointed to serve as the Deputy Coordinator of the Northern Virginia Human Trafficking Task Force.

WHEREAS, Justin Edward Fairfax received a scholarship to attend Columbia Law School where he was selected to be a member of the Columbia Law Review and earned his Juris Doctorate; received a scholarship to attend Duke University earning a degree in Public Policy Studies.

WHEREAS, served a three-year term on the Duke University Board of Trustees and is currently serving his third three-year term on the Board of Visitors of the Duke University Terry Sanford School of Public Policy.

Title: IB, AP, CI and CLEP Credit Acceptance Policy

Policy: 2204

Purpose

In accordance with state policy, Virginia State University (VSU) accepts credit from Advanced Placement (AP), International Baccalaureate (IB), Cambridge International (CI), and College Level Examination Program, (CLEP) examinations based on faculty and university program review. VSU awards AP, IB, CI and CLEP examination equivalencies not to exceed a maximum of 38 credit hours per student.

Authority, Responsibility, and Duties

The student must designate the Virginia State University Registrar as a recipient of the scores, and scores must be sent directly from the testing agency. Credit is awarded consistent with state and University policies and the sourcing agencies' guidelines.

Definitions

Policy Statements

IB Credit

The student must designate the Virginia State University Registrar as a recipient of the scores, and scores must be sent directly from the testing agency. Credit is awarded consistent with state and University policies and the sourcing agencies' guidelines.

VSU offers **possible credit** for scores of 4, 5, 6, or 7 on most high-level IB examinations and for scores of 5, 6, and 7 on most standard-level examinations in accordance with the pre-approved equivalencies for qualifying IB examination scores to be determined by the pertinent Academic Departments and published by the Office of the Registrar.

After matriculation, students should direct questions about their IB credit to the College Dean's office in which their major field of study is organized.

AP Credit

VSU awards advanced standing credit (course exemption and academic credit hours) to entering students who have qualifying scores (3 or higher) on the AP tests. Students may receive credit in any academic discipline in which an AP test is offered so long as they take the test before the end of their senior year of high school. The pre-approved equivalencies for qualifying AP examination scores are to be determined by the pertinent Academic Departments and published by the Office of the Registrar.

After matriculation, students should direct questions about their AP credit to the College Dean's office under which their major field of study is organized.

CI Credit

The University may grant credit for Cambridge International Examinations (CIE) levels Advanced (A) and Advanced Subsidiary (AS) offered through the University of Cambridge in England. These courses and examinations are administered through registered CIE Centers in public high schools throughout the United States. A-level syllabuses and exams cover approximately two years of college-level curriculum in a subject and the AS level syllabus and exam covers the first year of the two-year A-level curriculum.

Title: IB, AP, CI and CLEP Credit Acceptance Policy

Cambridge tests passed with final grades of A, B or C will be considered for advanced standing and credit for the corresponding courses at VSU. The applicability of such credit toward the student's degree program is interpreted by the department or school in which the student seeks a degree. Each Academic Department determines the course equivalencies for the various Cambridge examinations which are published by the Office of the Registrar.

CLEP Credit

Advanced standing based on completion of any College-level Examination Program's (CLEP) Exams is granted by Virginia State University. Each Department has established the criteria for awarding credit based on the recommendation of the faculty of the department. Each Academic Department determines the course equivalencies for the various CLEP examinations which are published by the Office of the Registrar.
