# **OPENING REMARKS**

The Rector expressed sincere condolences on behalf of the Board for the recent loss of board member Dr. William C. Bosher and the close family member of Student Government Association President, Mr. Hyisheem Calier, and asked all present to pause for a moment of reverent silence.

The Rector asked that VSU student Ms. Frednesha Sanders deliver the invocation.

Mr. Black welcomed new board member Dr. Daryl Dance. Dr. Dance shared her family lineage and connection with Virginia State University, and expressed her excitement to have the opportunity to serve on the board again.

Mr. Randall presented and moved for approval the following committee recommendations: Dr. Dance, Academic and Student Affairs and Institutional Advancement. The motion was seconded by Mr. Anas and carried by voice vote.

### PRESIDENT'S REMARKS

Interim President Dr. Pamela Hammond wished everyone a Happy New Year and spoke of the great things at Virginia State University to celebrate. Dr. Hammond expressed sincere gratitude towards her transition team for their support as together, she looks to move the University forward.

### **COMMITTEE REPORTS**

### Facilities, Finance and Audit Committee

(Committee members present: Black, Crittenden, Green, Hill, Humphries, Randall)

Mr. Black reported on behalf of the **Facilities, Finance and Audit Committee**, and asked that Mr. Meadows provide an update. Mr. Meadows discussed the Resolution Authorizing the President to Sign Letter to the Secretary of Finance certifying the University's compliance with the Board approved debt management policy allowing no more than a 7 percent debt burden as it relates to total operating expenses. Mr. Meadows reported that the University is currently at approximately 2.0 percent.

Mr. Meadows highlighted the Governor's introduced budget presentation and the Commonwealth's revenue picture. Discussion ensued.

Mr. Meadows provided information on the fiscal year 2014-2015 enrollment decline, the budget reduction finalization, the impact and strategies to reduce the revenue shortfall. Extensive discussion ensued.

Ms. Curtis-Taylor highlighted: the President's Campus Residence Audit, the status of the Corrective Action Plan: Audits and Investigations, Performance Audit of the Virginia State University Real Estate Foundation, update of the Office of the State Inspector General Annual Report, and the Internal Audit December 2014 Quarterly Report.

#### Academic and Student Affairs

(Committee members present: Dance, Denton, Green, Hill, Humphries)

Dr. Robert Denton, Chair of the Academic and Student Affairs Committee, asked that Dr. Hill highlight: enrollment management; enrollment projections; increasing community college transfer students; graduation and retention rates; current Six Year Plan strategies; and U.S. News and World Report ranking.

Ms. Davis reported that athletics at VSU continues to move in a positive direction for the student athletes both academically and athletically. Ms. Davis introduced Mr. Byron D. Thweatt, the new VSU football coach. Mr. Thweatt expressed gratitude, and shared his goals for the football program.

Mr. Harris and Ms. Crewe highlighted: key vacancies within Student Affairs; updated Satisfactory Academic Progress (SAP) numbers; impact on Residence Life operations; proposed dorm assistants grants and housing discounts; occupancy status; and sexual assault protocols.

#### Institutional Advancement

(Committee members present: Denton, Gillespie, Reid, Richardson)

Ms. Whitaker reported on behalf of the **Institutional Advancement Committee**, and provided an update on: organizational structure and staffing; Spider and Title III funds; major gifts; government funds; planned gifts; the fund comparison summary report; fundraising initiatives and opportunities; board fundraising challenge; and VSU Foundation and Virginia State University Alumni Association (VSUAA) update.

# **CLOSED SESSION**

In accordance with § 2.2-3711(A)(1) of the *Code of Virginia*, Ms. Reid moved to go into closed session at 2:55 p.m. for a discussion of personnel matters. The motion provided that Attorney Forehand, Ms. Degen, Dr. Hammond, Dr. Hill, Mr. Harris, Ms. Crewe and Dr. Wheelan attend the closed meeting as their presence was deemed necessary to aid the Board in its deliberations. The motion was seconded by Mr. Winstead, and carried by voice vote.

The Board reconvened in open session at 5:00 p.m. in accordance with § 2.2-3712(D) of the *Code of Virginia*. Ms. Reid conducted the poll in which all board members certified that the Board only discussed personnel matters. All board members present certified compliance with the Virginia Freedom of Information Act.

Ms. Karen Helderman, Project Manager, Auditor of Public Accounts, conducted a brief entrance conference for fiscal year 2014, highlighting: audit objectives, the audit plan and audit roles.

Mr. Meadows introduced Mr. John Dreiling and Mr. Kona Gray of Hanbury Evans Wright and Vlattas Company and Architecture Planning who provided a status of the campus Master Plan.

Mr. Harris introduced Mr. Monroe "Bud" Moseley and Ms. Michelle Cruz-Williams of the Search Firm, Isaacson, Miller. Mr. Mosely and Ms. Cruz-Williams provided: an overview of the search process; roles and responsibilities of the search committee; search schedule/workplan; definition of the position; and source/candidate suggestion form.

On behalf of the committee, Dr. Denton presented and moved for approval the confirmation of employment for Mr. Byron D. Thweatt as the Head Football Coach for Virginia State University. The motion carried by voice vote.

On behalf of the committee, Dr. Denton presented and moved for approval the recommendation that Dr. Emmanuel Omojokun serve as the Interim Dean of the College of Business and Dr. Robert Corley serve as the Interim Dean of the College of Education. The motion carried by voice vote.

#### Facilities, Finance and Audit Committee

On behalf of the committee, Mr. Winstead presented and moved for approval the Resolution Authorizing the President to Sign Letter to the Secretary of Finance certifying Virginia State University's compliance with Board approved debt management policy. The motion carried by voice vote.

Mr. Green presented and moved for approval the creation of a President's Residence committee to be chaired by Dr. Hobbs. The committee will re-evaluate the condition of the President's Residence and bring a recommendation back to the full board at the April 2015 meeting. Scheduled demolition shall be placed on hold until the evaluation is complete. The motion carried by voice vote.

#### Faculty Representative to the Board Report

Dr. Milton O. Faison shared his excitement regarding VSU becoming a university that is known for producing best practices for educating the student that we teach. The University has, and looks to host several development opportunities, focusing on student outcomes.

#### Student Representative to the Board Report

Mr. Hyshieem Calier, Student Government Association (SGA) President expressed sincere gratitude for the acts of kindness received as he experienced the death of a close family member. The SGA continues to work on the morale of the students and look for great things to come on the campus of VSU.
