

IMAGE PERMISSION AND USE AGREEMENT

This Image Permission and Use Agreement ("Agreement") is entered into on ("Effective Date") between ______ ("Authors"), who are affiliated with ______ and Virginia State University ("VSU" and "University"), an education corporation with its principle offices in South Chesterfield, Virginia, and its affiliated academic branches and institutions.

The University maintains an extensive archive of documents and other media. The University, through its Special Collections and University Archives ("VSUSCA") at its Johnson Memorial Library, manages those archives. The University grants permission for use of select archive media to publishers, producers, and authors under specific conditions. Authors seek to use specific media in their upcoming publication and would like to enter into this use agreement with University.

AGREEMENT

- A. For other good and valuable consideration, the receipt and sufficiency of which is acknowledged, University hereby grants **Authors, Publishers** and his/her/its agents, successors, assigns, to non-exclusive license to use the Licensed Materials for their publication tentatively titled ______ and all versions thereof, including republication and all promotional materials relating thereto ("Project") or any parts thereof.
- B. Specifically, Authors are granted permission to use media shown in Exhibit A.
- C. Permissions for publication or exhibition is for one time, one edition, on-publication use only. Additional uses for separate, new, or travelling exhibitions or publications or for future editions of publications and exhibits require additional fees and contracts.
- D. Only original reproductions supplied by Virginia State University Special Collections and Archives may be used for publication or exhibition. Use of materials held in VSUSCA copied from other sources is prohibited.
- E. Images are not to be altered or cropped in any way without prior approval by VSUSCA. If the altered image is approved, "Detail" must be noted in the caption.
- F. The license to reproduce may not be transferred to a third party, nor may any photographic materials, its derivatives or digital files be transferred to any other user.

- G. Virginia State University Special Collections and Archives reserves the right, at its sole discretion to deny license to reproduce to any applicant without explanation.
- H. Virginia State University Special Collections and Archives assumes no responsibility for resolving questions of copyright. The granting of publication of exhibition permission by Virginia State Special Collections and Archives does not remove the author's and/or publisher's responsibility to clear copyright and to guard against the infringement of rights that my be held by others.
- I. The University grants to the Author and Publishers permission to use of University's name in connection with the promotion of the Program and related funders/distributors ("Promotional Items") in all media now or after known, worldwide, in perpetuity. University agrees that Producer is under no obligation to use the Licensed Materials or Promotional Items in the Project or otherwise. University agrees that University has no rights to the Program or Promotional Items or to any derivatives or benefits of either.
- J. The Authors and Publishers warrant that their project will in no way negatively impact or effect the reputation of the University or the Commonwealth of Virginia.
- K. University represents and warrants that it has the right, capacity, and authority to enter into this agreement and that the Licensed Materials are wholly original to University and not copied in whole or in part from any other work and do not and will not infringe upon the copyright, literary, or other rights of any person or entity.
- L. The rights University has granted in this agreement will not violate any law, infringe on third-party rights, or conflict with or violate any commitment or understanding University has with any other person or entity.
- M. No payments will be required to be made to any person or entity in order for Producer to use the Licensed Materials or Promotional Items; however, should additional requests be made, the University has the right to seek reimbursement for costs and expenses.
- N. University represents and warrants that University has not and will not accept or pay any money, service, or other valuable consideration for the inclusion of any plug, reference, product identification, or other matter in any material prepared or performed hereunder.
- O. Please Note Copyright Restrictions May Apply. Under the copyright law of the United States (Title 17, U.S. Code); "Libraries and archives are authorized to furnish a photocopy or reproduction if it is not to be 'used for any purpose other than private study, scholarship, or research.' If a user makes a request for, or later uses a photocopy or reproduction for purposes in excess of 'fair use,' that user may be liable for copyright infringement."
- P. Copyright law protects unpublished as well as published materials. If you wish to use either published or unpublished materials from our collections in a publication or exhibit you must determine whether the work has passed into the public domain and is no longer under copyright protection or find the copyright holders and get permission to use the material. This agreement may not be amended unless agreed to by both parties in writing.
